Recommendation:

A. That Council write to the Minister for Heritage, Member for Vaucluse and the Director-General of the Department of Premier and Cabinet expressing its disappointment and concern about the lack of transparency in the reporting and decision making carried out by the Heritage Division.

Council has serious concerns about the way the submission was assessed and the significant departure from Council's nomination including the level of amendment without justification.

- B. That a submission to the Heritage Council be prepared that:
 - a. Generally supports the intention to list the Rose Bay Sea Wall, Promenade and its setting on the State Heritage Register;
 - b. Explains why the item as originally nominated by the Council to the Heritage Council has social heritage significance at a state level;
 - c. Provides further justification to support Council's original nomination and assessment that the body of water of Rose Bay is integral to the state heritage significance of the item; and
 - d. Recommends that the curtilage be amended to reflect the Council's original nomination and assessment of significance, which includes the waters of Rose Bay.
- C. That the Committee's recommendation proceeds to the Council meeting 12 May 2014 as a matter of urgency. This will enable Council staff to prepare a submission prior to the 16 May 2014 when the exhibition period for the draft nomination will close.

- That the DA Guide be amended to include the additional information and requirements В. identified in section 5.1 of the report to the Urban Planning Committee on 12 May 2014.
- That following completion of the fieldwork and when considering additional amendments to C. the Comprehensive DCP thought be given to including a separate set of controls for timber cottages and the individual listing of buildings.
- That a meeting of Paddington DCP Working Party be convened to brief and consult on D. proposed changes to the Paddington Heritage Conservation Area DCP in regard to timber cottages.
