### **Declarations of Interest**

Councillor Young declared a Pecuniary Interest in Urban Planning Committee Item R2 (Assessment of the Current Controls Applying to Residential 2(A) Zone and Residential 2(B) Zone Interface) as his property is possibly affected by this matter. Councillor Young left the meeting and did not participate in the debate or vote on the matter.

Councillor Wynne declared a Non Significant Non Pecuniary Interest in Development Control Committee Item R3 (10 Queens Avenue, Vaucluse) as an objector's daughter is in the same year at school as Councillor Wynne's daughter, however they are not friends. Councillor Wynne does not believe it would affect her vote.

Councillor Howe declared a Non Significant Non Pecuniary Interest in Notice of Motion 1 (Parking Restrictions on New South Head Road, Rose Bay) as he has an interest in a property in the area but the Motion does not affect his property. Councillor Howe does not believe it would affect his vote.

Councillor Jarnason declared a Pecuniary Interest in Urban Planning Committee Item R2 (Assessment of the Current Controls Applying to Residential 1(A) Zone and Residential 2(B) Zone Interface) as she owns property in Edgecliff Road, Woollahra. Councillor Jarnason left the meeting and did not participate in the debate or vote on the matter.

#### **General Declaration of Interest**

Councillor Howe also wished to advise the Council on a matter that does not relate to the Council Agenda but is a matter that has been raised several times in the Council and wants to raise it with a declaration of interest. Councillor Howe advised:

I am aware that Councillors have raised concerns regarding a conflict between myself and two matters, that is the architectural services that my firm is providing for 33 Cross Street Double Bay which I have already declared a Pecuniary Conflict of Interest to this Council and also a Question on Notice on 2<sup>nd</sup> of May 2011 to the Director of Planning regarding a report to a Notice of Motion tabled on 1<sup>st</sup> November 2010 by Councillor Petrie and myself.

I believe that I have fulfilled my obligations in respect to the first matter. For the second matter, when I asked the Question on Notice on 2<sup>nd</sup> May I was responding to correspondence addressed to me as a Ward Councillor from two property owners in Double Bay specifically relating to hotel development in Double Bay and neither of these people are related in any way to 33 Cross Street. My question was to ensure, as a Ward Councillor, I made every reasonable opportunity to avail the encouragement of future hotel development in Double Bay. My question, regarding the report to be tabled at Council was in no way a conflict either for myself as a Councillor or as Chair of a Committee that would consider the report. However after considering the matters raised by a number of Councillors here and other people who have spoken to me, I have carefully considered the matter over the last week and I can now see how some people might consider a perceived conflict of interest, particularly in relation to the fact that, as an architect, at some later date I might be involved in something in Double Bay in regards to that Notice of Motion and any subsequent report. I have written to the General Manager and when that report comes to Council I will excuse myself in relation to that Notice of Motion and any other matters in relation to that Notice of Motion.

As most Councillors were aware, I have been in South Africa and while I was there I had a meeting with the Council in Cape Town, the Executive Deputy Mayor, the Chief Whip and a number of the Councillors.

It was an interesting meeting because they pointed out they don't have Councils and Wards and so forth in the same way we do. They do have wards but they are different. They actually have 210 Councillors all of which meet in the one Council Chamber. It is run more or less like Parliament, they have a Speaker, they have Whips they even have a lovely mace to put in front of the Speakers. The elections were on two days after I had the meeting and it was very interesting to watch the way they had their meetings there and how they run them. It is almost like the NSW Parliament in that you have 210 Councillors, 200 of which come from the Wards and the other 10 are voted, like we vote for the Upper House in NSW. It was a very interesting meeting and I also extended the compliments of Your Worship and the fellow Councillors to them and sent an invitation on your behalf should any of them attend.

They gave me an absolutely beautiful book on Cape Town which I will declare to the General Manager. It has wonderful photographs of Cape Town and the surrounds and of the culture and the people. I also pointed out that we had a South African as Mayor at Council and a South African in Waverley Council, they were very impressed with that, and women Mayors as well.

  - (a) on the south side from Norwich Road to O'Sullivan Avenue
  - (b) on the north side from the entrance to Lyne Park to the STA Bus Stop opposite Norwich Road

for the purpose of restricting the length of time boat trailers, vehicles displaying advertising, and other vehicles can park in this vicinity.

2. That Council traffic and compliance staff determine the most appropriate parking restrictions to apply to this area which prevents long term parking of boat trailers, "advertising" trailers and other vehicles displaying business advertising without unreasonably affecting resident and commuter parking.

These parking restrictions are to prevent boat trailers, trailers with advertising hoardings and other vehicles displaying business advertising from being parked in this vicinity for extended periods, therefore adversely affecting the amenity of the area including restricting public views of the harbour from New South Head Road through Lyne Park and Tingara Reserve.
