The following questions were asked:-

Councillor Wynne asking:

Would it be possible to have a rubbish bin placed in Pannerong Reserve, Rose Bay? This park is used by many people who work in the area to have lunch and it is always badly littered.

If there is concern that a bin will encourage dumping of rubbish, could we place one on a trial basis to see if the impact is positive or negative?

Director Technical Services in response:

I thought there was a bin there but we can have one installed, that is not a problem.

Councillor Cavanagh asking:

Do we have a Register of Relationships, for same sex or heterosexual relationships? If you want to bring your other half into the country, one of the questions the Immigration Department asks is whether you have a Register at Councils or the States. Do we have such a register or are we proposing to have such a register?

General Manager in response:

No. I am not sure why we would actually be required, as a local authority, to hold such a register. I will take this On notice and will make further enquiries.

Councillor Shapiro asking:

Please can we investigate the installation of a pedestrian crossing on Old South Head Road at the corner of Wilberforce Avenue, Rose Bay? This is an extremely busy corner and twice in the last Council I have asked for this to be followed up.

Director Technical Services in response:

On notice.

Councillor Carmichael asking:

On the corner of Tindale Lane and Edgecliff Road there were once bollards installed protecting an old heritage home from being smashed by cars attempting to park. Is it possible to have new metal bollards installed to replace the absent old ones?

Director Technical Services in response:

On notice.

Councillor Young asking:

Given that the Director General of the Department of Planning, when declaring the Ashington development in Cross Street, Double Bay to be a development to which Part 3A of the Environmental Planning and Assessment Act applied, did so on the purported basis that it was "development for the purpose of tourist related facilities", and given that the proposal is to demolish a 166 room hotel and build high rise units with retail and a small 60 room boutique hotel below, has Council considered seeking legal advice on the validity of that declaration?

Director Planning and Development in response:

No we have not considered obtaining legal advice in relation to that matter. I can say that I did provide some earlier advice on this to the Urban Planning Committee earlier tonight. The content of that advice is that there may be an argument that there has been some degree of invalidity in the way the matter has been declared but the conclusion I drew after looking at all the circumstances was that even if the Council were successful in such proceedings there is a very easy remedy that the Department or the Minister can take. At the end of the day you would have to question the merit of the commencement of such proceedings.

Councillor Shoebridge asking:

Noting any further calling in will be subject of political considerations as well as legal considerations, can we obtain legal advice on the legality of the calling in of the Ashington development?

Director Planning and Development in response:

After discussion with the General Manager we will be reporting through the appropriate committee of Council on this project and in my report I will provide the Council with a detailed history of this project including the history of the declaration and the manner in which the Department went about that declaration. I think that information will be sufficient to enable Councillors to make some judgement as to whether or not they may wish to take some action in relation to challenging the declaration.
