## **Additional Information:**

Woollahra Municipal Council will determine your eligibility to receive a rebate of up to \$250 on your rates account. You may also be eligible to receive up to \$87.50 on your annual water charges and up to \$87.50 off your annual sewerage charges, if your council provides these services. Alternatively, if your council does not provide these services, contact your water/sewer service provider for more information.

- Holders of the PCC (Pensioner Concession Card);
- Holders of a gold card embossed with 'TPI' (Totally Permanently Incapacitated);
- Holders of a gold card embossed with 'EDA' (Extreme Disablement Adjustment);
- War widow or widower or wholly dependent partner entitled to the Pensioner Concession Card\*.
